**SYNOPSIS**

“College Mental Health Services Act”; establishes grant program for public institutions of higher education and requires public institutions of higher education to report certain information concerning mental health treatment and suicides.

1 AN ACT concerning mental health on college campuses and  
2 supplementing chapter 62 of Title 18A of the New Jersey  
3 Statutes.

4  
5 **BE IT ENACTED** *by the Senate and General Assembly of the State*  
6 *of New Jersey:*

7  
8 1. This act shall be known and may be cited as the “College  
9 Mental Health Services Act.”

10  
11 2. a. There is established in the Office of the Secretary of  
12 Higher Education the “College Mental Health Services Grant  
13 Program.” The purpose of the program shall be to allocate grant  
14 moneys to public institutions of higher education to improve access  
15 to mental health services on the campuses of the institutions.

16 b. A grant received by a public institution of higher education  
17 under the program shall be specifically used for efforts to improve  
18 student access to, and the timeliness of the provision of, mental  
19 health services and supports. The grant may be used for, but is not  
20 limited to:

21 (1) developing initiatives to reduce wait times for students  
22 seeking mental health services and supports;

23 (2) hiring additional mental health professionals to provide  
24 mental health services and supports to students at the institution;

25 (3) contracting with independent public or private entities to  
26 provide mental health services and supports;

27 (4) creating methods to enhance the identification of students  
28 who may be experiencing personal, school, or family difficulties  
29 impacting the student’s mental health; and

30 (5) implementing efforts to increase awareness among students  
31 of existing on-campus and community resources for students  
32 experiencing mental health difficulties.

33 c. To be eligible for consideration for a grant award, a public  
34 institution of higher education shall submit an application to the  
35 Secretary of Higher Education, in accordance with application  
36 procedures and requirements prescribed by the secretary. A grant  
37 application shall include a complete description of the institution’s  
38 specific plans and objectives for the use of the grant funds and any  
39 other information specified by the secretary.

40 d. The secretary shall establish selection criteria for the  
41 awarding of grant funds under the program. The secretary shall  
42 establish the amount for each grant that is approved.

43  
44 3. a. There is created within the Office of the Secretary of  
45 Higher Education a fund to be known as the “College Mental Health  
46 Services Grant Fund.” The fund shall be used to provide grants to  
47 New Jersey public institutions of higher education under the

1 “College Mental Health Services Grant Program” established  
2 pursuant to section 2 of this act.

3 b. The fund shall annually be credited with moneys  
4 appropriated by the State, any moneys received by the State from  
5 corporate donors or other private sector support, and any federal  
6 funds which may become available for higher education and mental  
7 health services and supports purposes.

8

9 4. a. Beginning with the first full academic year following the  
10 date of enactment of this act, a public institution of higher education  
11 shall provide for public inspection on its Internet website  
12 information on:

13 (1) the ratio of students to mental health professionals at the  
14 institution;

15 (2) the total number of students who had appointments with a  
16 mental health professional at the institution;

17 (3) the number of students who had only one appointment with a  
18 mental health professional at the institution;

19 (4) the number of students who had three or more appointments  
20 with a mental health professional at the institution;

21 (5) the total number of appointments made by students with  
22 mental health professionals at the institution;

23 (6) the average number of appointments for those students who  
24 had more than one appointment with a mental health professional at  
25 the institution;

26 (7) the average wait time for students to meet with a mental  
27 health professional at the institution;

28 (8) the number of students who were referred to outside mental  
29 health services; and

30 (9) the number of students who were referred to emergency care  
31 due to mental health concerns.

32 The information required pursuant to this subsection shall be  
33 recorded for each semester and shall be posted no more than 60  
34 days following the end of each semester. The information shall be  
35 posted on the institution’s Internet website in a prominent and  
36 easily accessible location.

37 b. Beginning with the first full academic year following the date of  
38 enactment of this act, a public institution of higher education shall  
39 report to the Secretary of Higher Education on:

40 (1) the total number of students enrolled in the institution who  
41 committed suicide in the previous academic year; and

42 (2) the total number of students enrolled in the institution who  
43 attempted to commit suicide in the previous academic year.

44 The secretary shall report the total number of student suicides  
45 and student suicide attempts at all public institutions of higher  
46 education combined to the Governor, and to the Legislature pursuant  
47 to section 2 of P.L.1991, c.164 (C.52:14-19.1). The secretary may

1 authorize limited disclosure of the data collected pursuant to this  
2 subsection for use in medical, academic, or policy studies.

4 5. This act shall take effect immediately.

#### STATEMENT

9 This bill, known as the “College Mental Health Services Act,”  
10 establishes in the Office of the Secretary of Higher Education the  
11 “College Mental Health Services Grant Program.” The purpose of  
12 the program will be to allocate grant moneys to senior public  
13 institutions of higher education and county colleges in the State to  
14 establish or improve access to mental health services on the  
15 campuses of the institutions.

16 A grant received by a public institution of higher education  
17 under the program is to be specifically used for efforts to improve  
18 student access to, and the timeliness of the provision of, mental  
19 health services and supports. The grant may be used for, but is not  
20 limited to: developing initiatives to reduce wait times for students  
21 seeking mental health services and supports; hiring additional  
22 mental health professionals to provide mental health services and  
23 supports to students at the institution; contracting with independent  
24 public or private entities to provide mental health services and  
25 supports; creating methods to enhance the identification of students  
26 who may be experiencing personal, school, or family difficulties  
27 impacting the student’s mental health; and implementing efforts to  
28 increase awareness among students of existing on-campus and  
29 community resources for students experiencing mental health  
30 difficulties.

31 The bill also requires public institutions of higher education to  
32 post on their Internet websites the following information for each  
33 semester: the ratio of students to mental health professionals at the  
34 institution; the total number of students who had appointments with  
35 a mental health professional at the institution; the number of  
36 students who had only one appointment with a mental health  
37 professional; the number of students who had three or more  
38 appointments with a mental health professional; the total number of  
39 appointments made by students with mental health professionals;  
40 the average number of appointments for those students who had  
41 more than one appointment with a mental health professional; the  
42 average wait time for students to receive appointments with a  
43 mental health professional; the number of students who were  
44 referred to outside mental health services; and the number of  
45 students who were referred to emergency care due to mental health  
46 concerns. The information will be updated no more than 60 days  
47 following the end of each semester and will be posted on the  
48 institution’s website.

1       The bill also requires each public institution of higher education  
2       to annually report to the Secretary of Higher Education on the total  
3       number of students enrolled in the institution who committed  
4       suicide in the previous academic year, and the total number of  
5       students enrolled in the institution who attempted to commit suicide  
6       in the previous academic year. The secretary must report the total  
7       number of student suicides and student suicide attempts at all public  
8       institutions of higher education combined to the Governor, and to  
9       the Legislature. The secretary may also authorize limited disclosure  
10      of the collected data in medical, academic, or policy studies.
