**SYNOPSIS**

Permits conduct of Queen of Hearts raffle games.

1 AN ACT concerning the types of raffle games permitted to be  
2 conducted by licensed organizations in this State and  
3 supplementing the “Raffles Licensing Law,” P.L.1954, c.5  
4 (C.5:8-50 et seq.).  
5

6 **BE IT ENACTED** by the Senate and General Assembly of the State  
7 of New Jersey:  
8

9 1. a. The Legalized Games of Chance Control Commission  
10 shall adopt regulations, pursuant to the “Administrative Procedure  
11 Act,” P.L.1968, c.410 (C.52:14B-1 et seq.), authorizing licensees to  
12 hold and conduct Queen of Hearts raffle games. The control  
13 commission may specify any requirement applicable to the conduct  
14 of Queen of Hearts raffle games that the control commission may  
15 deem necessary in accordance with this section.

16 b. A “Queen of Hearts raffle” means a raffle game utilizing a  
17 Queen of Hearts raffle board onto which 54 playing cards can be  
18 placed facedown, side-by-side, and held securely by a locking,  
19 transparent cover, which playing cards shall be thoroughly shuffled  
20 and from which the participant holding the winning raffle ticket  
21 drawn at random from a raffle ticket drum or receptacle shall be  
22 entitled to “Search for the Queen of Hearts” by selecting one of the  
23 facedown playing cards.

24 When the playing card selected is not the Queen of Hearts, the  
25 card shall be placed out of play, and the holder of the winning raffle  
26 ticket selecting that card shall be immediately awarded a cash prize  
27 valued according to the schedule set forth in regulation by the  
28 Legalized Games of Chance Control Commission. The raffle  
29 drawings shall be conducted weekly until a person selects the  
30 Queen of Hearts. When the playing card selected is the Queen of  
31 Hearts, the holder of the winning raffle ticket selecting that card  
32 shall be awarded 50 percent of the prize, with the remainder of the  
33 prize retained by the licensee as proceeds from conducting the  
34 raffle.

35 c. The licensee may use the net proceeds derived from the  
36 conduct of Queen of Hearts raffle games in any manner allowable  
37 by law and in accordance with State regulations.

39 2. This act shall take effect immediately.

42 STATEMENT  
43

44 This bill permits raffle licensees to conduct of Queen of Hearts  
45 raffle games.

46 Under current law, municipalities where voters have approved a  
47 referendum to allow raffle games may license eligible organizations  
48 to conduct these games. The Legalized Games of Chance Control

1 Commission in the Department of Law and Public Safety regulates  
2 the conduct of these games.

3 Under Article IV, Section VII, paragraph 2, subparagraph B of  
4 the State Constitution, and under the Raffles Licensing Law,  
5 eligible organizations may apply for a license to conduct raffles.  
6 Bona fide organizations or associations of veterans; churches or  
7 religious congregations and religious organizations; charitable,  
8 educational, and fraternal organizations; civic and service clubs;  
9 senior citizen associations and clubs; officially recognized  
10 volunteer fire companies; and officially recognized volunteer first  
11 aid or rescue squads are eligible to apply for a license.

12 This bill permits eligible organizations to conduct Queen of  
13 Hearts raffle games. A “Queen of Hearts raffle” means a raffle  
14 game utilizing a Queen of Hearts raffle board onto which 54  
15 thoroughly shuffled playing cards are placed facedown, side-by-  
16 side. Raffle tickets are placed into a ticket drum or other receptacle  
17 and a winning ticket is drawn at random. The participant holding  
18 the winning raffle ticket is entitled to “Search for the Queen of  
19 Hearts” by selecting one of the facedown playing cards. When the  
20 playing card selected is not the Queen of Hearts, the card is placed  
21 out of play, and the person is awarded a cash prize valued according  
22 to a certain schedule. The raffle drawings are conducted weekly  
23 until a person selects the Queen of Hearts. When a person selects  
24 the Queen of Hearts, that person will be awarded 50 percent of the  
25 prize, and the remainder of the prize will be retained by the licensee  
26 as proceeds from conducting the raffle.

27 The bill specifies that the licensee may use the net proceeds  
28 derived from the conduct of Queen of Hearts raffle games in any  
29 manner allowable by law and in accordance with State regulations.  
30 The bill directs the Legalized Games of Chance Control  
31 Commission to adopt the necessary rules and regulations for the  
32 conduct of Queen of Hearts raffle games.
