Provides additional State school aid to certain school districts; appropriates \$103,023,579.

1 AN ACT concerning the provision of State school aid for certain
2 school districts and making an appropriation.

4 **BE IT ENACTED** by the Senate and General Assembly of the State
5 of New Jersey:

7 ¹**[**1. a. Notwithstanding the provisions of P.L.2018, c.67
8 (C.18A:7F-67 et al.) or any other law, rule, or regulation to the
9 contrary, a school district for which the State aid differential, as
10 defined in section 3 of P.L.2018, c.67 (C.18A:7F-67), is positive in
11 the 2023-2024 school year and that is subject to a State school aid
12 reduction pursuant to the provisions of section 4 of P.L.2018, c.67
13 (C.18A:7F-68) shall receive an amount of State school aid, in
14 addition to the amount proposed in the State aid notice for the 2023-
15 2024 school year distributed to school districts in March 2023,
16 equal to 66 percent of the difference between the amount of aid
17 received for the 2022-2023 school year and the amount of aid
18 proposed for the 2023-2024 school year. To receive the amounts
19 provided pursuant to this section, a school district shall submit to
20 the Commissioner of Education, in a manner and form to be
21 prescribed by the commissioner, a written plan explaining how the
22 district intends to fund operations in future school years in which
23 the district does not receive Stabilization Aid or similar
24 supplemental State school aid.

25 b. In addition to the amounts proposed in the State aid notices
26 for the 2023-2024 school year distributed to school districts in
27 March 2023, there is appropriated the sum of \$102,784,455 from
28 the Property Tax Relief Fund to the Department of Education to
29 effectuate the provisions of this act. The aid shall be distributed to
30 school districts in the amounts as follows:
