Requires MVC to provide customers with option to receive certain documents in-person same day or via mail.

1 AN ACT concerning the issuance of certain documents by the New
2 Jersey Motor Vehicle Commission and supplementing Title 39 of
3 the Revised Statutes.

5 **BE IT ENACTED** by the Senate and General Assembly of the State
6 of New Jersey:

8 1. a. Notwithstanding any law, rule, or regulation to the
9 contrary, the New Jersey Motor Vehicle Commission shall provide
10 all customers who have an in-person appointment to receive a new
11 document listed in subsection b. of this section or renew a
12 document listed in subsection b. of this section at any commission
13 agency location within the State with the option to receive the new
14 or renewed document on the same day at the commission agency
15 location or be sent the new or renewed document in the mail.

16 b. The commission shall make the following documents
17 available for same-day issuance pursuant to subsection a. of this
18 section, at a minimum:

- 19 (1) standard basic driver's license;
20 (2) standard motorcycle license;
21 (3) standard special learner's permit;
22 (4) standard examination permit;
23 (5) standard probationary driver's license;
24 (6) standard non-driver identification card;
25 (7) REAL ID basic driver's license;
26 (8) REAL ID motorcycle license;
27 (9) REAL ID probationary driver's license;
28 (10) REAL ID identification card; and
29 (11) commercial driver's license.

31 2. This act shall take effect on the first day of the third month
32 after the month in which P.L. , c. (C.) (pending before the
33 Legislature as this bill) is enacted, but the New Jersey Motor
34 Vehicle Commission may take anticipatory actions necessary to
35 implement the provisions of this act.

40 This bill requires the New Jersey Motor Vehicle Commission
41 (commission) to provide all customers who have an in-person
42 appointment to receive certain documents at any commission
43 agency location within the State with the option to receive the new
44 or renewed document on the same day at the commission agency
45 location or be sent the new or renewed document in the mail. The
46 types of documents to be available to be created on the same day at
47 the commission agency location or be sent via mail pursuant to this
48 bill are as follows: (1) standard basic driver's license; (2) standard

1 motorcycle license; (3) standard special learner's permit; (4)
2 standard examination permit; (5) standard probationary driver's
3 license; (6) standard non-driver identification card; (7) REAL ID
