## P.L. 2023, CHAPTER 180, approved November 27, 2023 Senate, No. 1553 (Fourth Reprint)

**AN ACT** concerning teacher certification and supplementing chapter 26 of Title 18A of the New Jersey Statutes.

**BE IT ENACTED** by the Senate and General Assembly of the State of New Jersey:

<sup>4</sup>[1. a. The State Board of Education shall authorize the issuance of an alternative certificate of eligibility with advanced standing to a teacher candidate who meets all other eligibility requirements for a certificate of eligibility with advanced standing, except <sup>1</sup>for<sup>1</sup> the requirement to achieve a minimum passing score on an appropriate State test of subject matter knowledge and all other alternative requirements or exceptions to achieving a passing score on an appropriate State test of subject matter knowledge.

b. The holder of an alternative certificate authorized pursuant to subsection a. of this section shall be eligible to receive a standard certificate from the State Board of Education upon completion of four years of continuous employment as a teacher in <sup>1</sup> [the State's public schools] a school district, charter school, renaissance school project, or an approved private school for students with disabilities <sup>1</sup>, provided that the teacher completes all applicable requirements for the standard certificate.] <sup>4</sup>

**L**2. **1**. **4** a. The State Board of Education shall authorize the issuance of an alternative certificate of eligibility to a teacher candidate who meets all other eligibility requirements to receive a certificate of eligibility, except <sup>1</sup>for<sup>1</sup> the requirement to achieve a minimum score on a Commissioner of Education-approved test of basic reading, writing, and mathematical skills and all other alternative basic skills requirements or exceptions <sup>4</sup>**[**; or the requirement to achieve a minimum passing score on an appropriate State test of subject matter knowledge and all other alternative requirements or exceptions to achieving a passing score on an appropriate State test of subject matter knowledge **1**<sup>4</sup>.

b. The holder of an alternative certificate authorized pursuant to subsection a. of this section shall be eligible to receive a standard certificate from the State Board of Education upon completion of four years of continuous employment as a teacher in <sup>1</sup> [the State's public schools] a school district, charter school, renaissance school project,
