1 AN ACT concerning the performance of ultrasounds on pregnant 2 women by licensed health care professionals and supplementing 3 Title 45 of the Revised Statutes. 4 5 **BE IT ENACTED** by the Senate and General Assembly of the State 6 of New Jersey: 7 8 1. a. The performance of any ultrasound on a pregnant woman 9 in a limited service pregnancy center shall be performed by a health 10 care professional whose scope of practice includes performing 11 ultrasounds. 12 b. For the purposes of this section: 13 "Health care professional" means a person licensed or otherwise 14 authorized pursuant to Title 45 or Title 52 of the Revised Statutes to 15 practice a health care profession that is regulated by the Director of 16 the Division of Consumer Affairs or by one of the professional 17 licensing boards located thereunder. "Limited service pregnancy center" means an organization, 18 19 including a pregnancy counseling organization or crisis pregnancy 20 center, that for a fee or free of charge provides pregnancy 21 counseling or information but does not perform abortions or make 22 referrals to an abortion provider and is not licensed or certified by 23 this State or the federal government to provide medical or health 24 care services. "Limited service pregnancy center" shall not include 25 a health care provider, a hospital, an abortion clinic, or a family 26 planning clinic that performs abortions, provides contraception, or 27 provides abortion or contraception referrals. 28 29 2. This act shall take effect immediately. 30 31 **STATEMENT** 32 33 34 This bill provides that the performance of any ultrasound on a 35 pregnant woman in a limited service pregnancy center shall be performed by a health care professional whose scope of practice 36 37 includes performing ultrasounds. The bill defines "health care professional" as a person licensed 38 39 or otherwise authorized pursuant to Title 45 or Title 52 of the 40 Revised Statutes to practice a health care profession that is 41 regulated by the Director of the Division of Consumer Affairs or by 42 one of the professional licensing boards located thereunder. 43 "Limited service pregnancy center" is defined as an organization, 44 including a pregnancy counseling organization or crisis pregnancy 45 center, that for a fee or free of charge provides pregnancy 46 counseling or information but does not perform abortions or make 47 referrals to an abortion provider and is not licensed or certified by 48 this State or the federal government to provide medical or health
