Provides project grants under “Securing Our Children’s Future Fund” for career and technical education at county colleges; appropriates \$19,993,837.

1 AN ACT concerning project grants under the “Securing Our  
2 Children’s Future Fund” to provide career and technical  
3 education at county colleges and making an appropriation.  
4

5 **BE IT ENACTED** *by the Senate and General Assembly of the State*  
6 *of New Jersey:*  
7

8 1. a. There is appropriated from the “Securing Our Children’s  
9 Future Fund,” established pursuant to section 13 of P.L.2018, c.119,  
10 to the Secretary of Higher Education the sum of \$19,993,837 to  
11 provide career and technical education grants to county colleges.  
12 Project grants shall be awarded in the amounts set forth in  
13 subsection b. of this section.

14 b. Project grants shall be awarded in the amounts as follows:

15 (1) \$4,000,000 to Camden County College in Blackwood and  
16 Camden, Camden County;

17 (2) \$4,000,000 to Essex County College in Newark, Essex  
18 County;

19 (3) \$3,381,337 to Passaic County Community College in Wayne,  
20 Passaic County;

21 (4) \$4,000,000 to Raritan Valley Community College in  
22 Branchburg, Somerset County;

23 (5) \$3,750,000 to Rowan College of South Jersey in Sewell,  
24 Gloucester County; and

25 (6) \$862,500 to Sussex County Community College in Newton,  
26 Sussex County.

28 2. The expenditure of sums appropriated by this act shall be  
29 subject to the provisions and conditions of the “Securing Our  
30 Children’s Future Bond Act,” P.L.2018, c.119.  
31

32 3. This act shall take effect immediately.

35 STATEMENT

37 This bill appropriates a total of \$19,993,837 from the “Securing  
38 Our Children’s Future Fund” for career and technical education  
39 grants to the State’s county colleges. The expenditure of the grants  
40 would be subject to the provisions and conditions of the “Securing  
41 Our Children’s Future Bond Act.”
