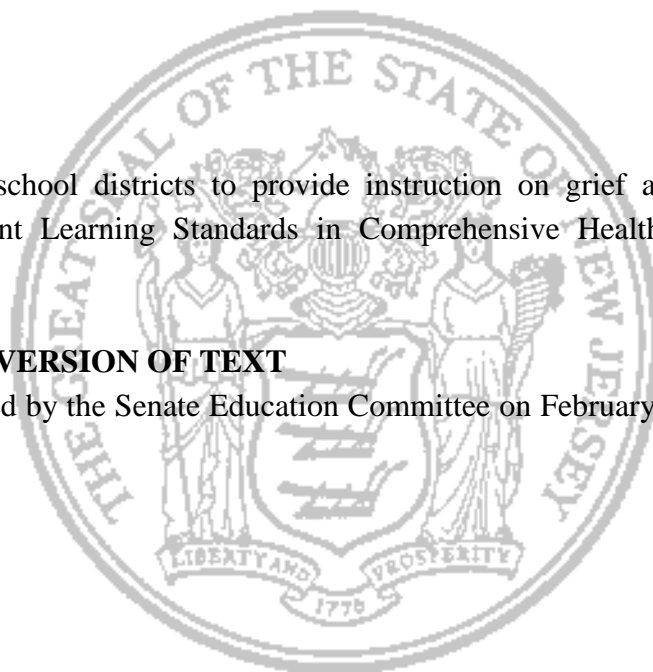

SYNOPSIS

Requires school districts to provide instruction on grief as part of New Jersey Student Learning Standards in Comprehensive Health and Physical Education.

CURRENT VERSION OF TEXT

As reported by the Senate Education Committee on February 23, 2023, with amendments.

1 AN ACT concerning the provision of grief instruction in public
2 schools and supplementing chapter 35 of Title 18A of the New
3 Jersey Statutes.

5 **BE IT ENACTED** by the Senate and General Assembly of the State
6 of New Jersey:

8 1. a. ¹The State Board of Education shall adopt New Jersey
9 Student Learning Standards in Comprehensive Health and Physical
10 Education pertaining to grief.

11 b.¹ A school district shall include instruction on grief in an
12 appropriate place in the curriculum of students in grades eight
13 through 12 as part of the district's implementation of the New
14 Jersey Student Learning Standards in Comprehensive Health and
15 Physical Education.

16 ¹**[b.] c.**¹ The instruction shall include, at a minimum,
17 information on:

- 18 (1) the physical, emotional, and behavioral symptoms of grief;
19 (2) coping mechanisms and techniques for handling grief and
20 loss; and
21 (3) resources available to students, including in-school support,
22 mental health crisis support, and individual and group therapy.

23 ¹**[c.] d.**¹ The Commissioner of Education shall provide school
24 districts with age-appropriate ¹**[sample learning activities and]**¹
25 resources ¹**[designed to implement the requirement established**
26 **pursuant to subsection a. of this section]** concerning grief¹.

28 2. This act shall take effect immediately ¹**[and shall first apply to**
29 **the first full school year following the date of enactment]**. The
30 standards adopted by the State Board of Education pursuant to
31 section 1 of P.L. , c. (C.) (pending before the Legislature as
32 this bill) shall occur concurrent with each update to the New Jersey
33 Student Learning Standards required pursuant to section 4 of
34 P.L.2007, c.260 (C.18A:7F-46).¹
