1	AN ACT concerning human trafficking and underserved
2	communities and supplementing Title 52 of the Revised Statutes.

4	BE IT ENACTED by the Senate and General Assembly of the State
5	of New Jersey:

7	1. a. The Attorney General shall allocate and utilize resources
8	in the Department of Law and Public Safety to perform functions
9	designed to address the specific needs and vulnerabilities related to
10	human trafficking which are experienced by members of
11	underserved communities, particularly girls and women of color.
12	b. The functions to be performed pursuant to subsection a. of
13	this section shall include, but not be limited to:
14	(1) coordinating with the State, municipal, and county law
15	enforcement agencies to investigate cases related to human
16	trafficking in underserved communities;
17	(2) coordinating with relevant government entities, including,
18	but not limited to the Victims of Crime Compensation Office,
19 20	established pursuant to section 2 of P.L.2007, c.95 (C.52:4B-3.2)
21	and the Commission on Human Trafficking, established pursuant to section 1 of P.L.2013, c.51 (C.52:17B-237), and community-based
22	organizations to create and administer programs to connect victims

32	This bill requires the Attorney General to address human
33	trafficking related to members of underserved communities.
34	Under the bill, the Attorney General would be required to
35	allocate and utilize resources in the Department of Law and Public
36	Safety to perform functions designed to address the specific needs
37	and vulnerabilities related to human trafficking which are
38	experienced by members of underserved communities, particularly
39	girls and women of color.
40	The bill provides that the responsibilities would include, but not
41	be limited to:
42	(1) coordinating with the State and municipal and county law
43	enforcement agencies to investigate cases related to human
44	trafficking in underserved communities;
45	(2) coordinating with relevant government entities, including,
