## **SYNOPSIS**

Requires State Board of Education to authorize alternate route to expedite teacher certification of persons employed as paraprofessionals in school districts.

1 AN ACT concerning teacher certification and supplementing chapter 2 26 of Title 18A of the New Jersey Statutes. 3 4 **BE IT ENACTED** by the Senate and General Assembly of the State 5 of New Jersey: 6 7 1. a. The State Board of Education shall authorize an alternate 8 route to expedite the teacher certification of persons who are 9 employed or have been employed by a school district as a 10 paraprofessional or an instructional assistant. 11 The Commissioner of Education shall b develop 12 recommendations for the alternate route program authorized pursuant to subsection a. of this section and shall submit the 13 recommendations to the State Board of Education. In developing 14 15 the recommendations, the commissioner shall consult with 16 representatives of the education community including, but not limited to, the New Jersey Education Association, the New Jersey 17 School Boards Association, the New Jersey Principals and 18 Supervisors Association, the New Jersey Association of School 19 20 Administrators, and the State Professional Learning Committee. c. In addition to any other requirements established by the State 21 22 Board of Education, the alternate route program authorized pursuant 23 to subsection a. of this section shall include the following: 24 (1) a formula for applying a candidate's direct classroom service 25 to any student teaching requirements, provided that the candidate is 26 currently employed by a school district and is providing direct 27 classroom service, including tutoring. Under the formula, the direct classroom service shall earn the candidate full credit, if appropriate; 28 29 (2) a requirement that the school district in which the candidate 30 is currently employed permit the candidate to perform any required 31 student teaching in the school district while, if possible, continuing 32 employment as a paraprofessional or an instructional assistant; and 33 (3) a formula to allow a grade point average waiver for 34 candidates who otherwise demonstrate qualification for the expedited teacher certification. 35 36 37 2. This act shall take effect immediately. 38 39 40 **STATEMENT** 41 42 This bill requires the State Board of Education to authorize an alternate route to expedite the teacher certification of persons who 43 44 are employed or have been employed by a school district as a 45 paraprofessional or an instructional assistant. 46 The Commissioner of Education is to develop recommendations 47 for the alternate route and those recommendations are required to be submitted to the State board. In developing the recommendations, 48

1 the commissioner is to consult with representatives of the education 2 community, including the New Jersey Education Association, the 3 New Jersey School Boards Association, the New Jersey Principals 4 and Supervisors Association, the New Jersey Association of School 5 Administrators, and the State Professional Learning Committee. 6 The bill provides that in addition to any other requirements 7 established by the State Board of Education, the alternate route 8 program is required to include:
