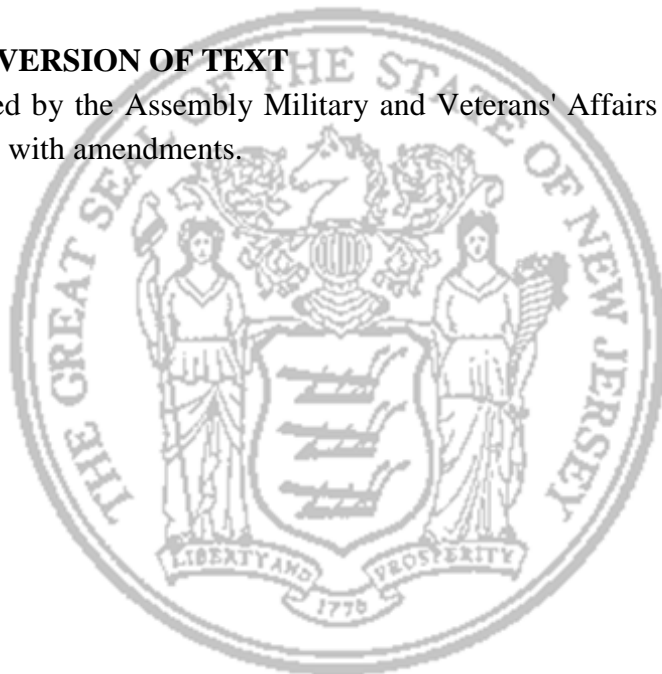

SYNOPSIS

Exempts disabled veterans and Purple Heart recipients from payment of municipal parking meter fees when vehicle bears veteran's or recipient's special license plate or placard issued by MVC.

1 AN ACT concerning an exemption from payment of municipal
2 parking meter fees by certain persons under certain
3 circumstances, and amending P.L.2015, c.218.

5 **BE IT ENACTED** by the Senate and General Assembly of the State
6 of New Jersey:

8 1. Section 1 of P.L.2015, c.218 (C.39:4-207.10) is amended to
9 read as follows:

10 1. a. A person who is a disabled veteran or a recipient of the
11 Purple Heart is exempt from the payment of municipal parking
12 meter fees when a motor vehicle **[owned by the disabled veteran or**
13 **the Purple Heart recipient]** displays ¹**[a]** disabled veteran's or
14 Purple Heart license plates or a placard issued by the New Jersey
15 Motor Vehicle Commission pursuant to the provisions of Title 39 of
16 the Revised Statutes **[**, unless the vehicle has been parked in one
17 location for more than 24 hours**]**. The exemption provided under
18 this subsection shall apply only when the disabled veteran or
19 recipient of the Purple Heart to whom the special license plates or
20 placards have been issued is either the driver **[,]** or a passenger **[,]**
21 of the motor vehicle and shall not apply when the motor vehicle is
22 parked for more than 24 hours at one location where the motor
23 vehicle is subject to a municipal parking meter fee.

24 b. The Chief Administrator of the New Jersey Motor Vehicle
25 Commission shall promulgate such rules and regulations as may be
26 necessary to effectuate the provisions of subsection a. of this
27 section, pursuant to the "Administrative Procedure Act," P.L.1968,
28 c.410 (C.52:14B-1 et seq.), and shall include provisions for the
29 issuance of disabled veteran's or Purple Heart recipient's placards
30 by the commission.
