SYNOPSIS

Removes exception to civil service working test period for political subdivision employees.

1 AN ACT concerning the working test period for political subdivision
2 employees and amending N.J.S.11A:4-15.

4 **BE IT ENACTED** by the Senate and General Assembly of the State
5 of New Jersey:

7 1. N.J.S.11A:4-15 is amended to read as follows:

8 11A:4-15. Working test period. The purpose of the working test
9 period is to permit an appointing authority to determine whether an
10 employee satisfactorily performs the duties of a title. A working
11 test period is part of the examination process which shall be served
12 in the title to which the certification was issued and appointment
13 made. The commission shall provide for:

14 a. A working test period following regular appointment of four
15 months, which may be extended to six months at the discretion of
16 the commission, except that **the working test period for political**
17 **subdivision employees shall be three months and** the working test
18 period for entry level law enforcement, correction officer, and
19 firefighter titles shall be 12 months;

20 b. Progress reports to be made by the appointing authority and
21 provided to the employee at such times during the working test
22 period as provided by rules of the commission and a final progress
23 report at the end of the entire working test period shall be provided
24 to the employee and the commission;

25 c. Termination of an employee at the end of the working test
26 period and termination of an employee for cause during the working
27 test period; and

28 d. The retention of permanent status in the lower title by a
29 promoted employee during the working test period in the higher
30 title and the right to return to such permanent title if the employee
31 does not satisfactorily complete the working test period, but
32 employees removed for cause during a working test period shall not
33 be so returned.

41 Under current law, for most civil service employees, the Civil
42 Service Commission provides for a working test period of four
43 months, which may be extended to six months at the discretion of
44 the commission, except that the working test period for political
45 subdivision employees is three months. This bill removes the

1 exception for political subdivision employees. Under the bill, the
